






September 5-6, 2019, a joint conference was held in Bishkek by the Association of Central Securities Depositories of Eurasia (AECSD) and the International Association of Exchanges (IAE) entitled: "Integration Processes in Financial Markets: Eurasia and the Global Economy" with the participation of executives and experts from the CIS countries and the global community. The Conference also included the general meeting of the AECSD members.





The President of the Central Securities Depository of Kyrgyzstan, Aziza Yuldasheva, made welcoming and closing remarks. The event was moderated by the President of the Kyrgyz Stock Exchange Almaz Shabdanov.

The conference was attended by over 100 visitors, among whom there were representatives of the central depositories of the CIS countries, international central depositories, exchanges, regulators, investment banks, analytical agencies and international organizations. The conference also welcomed the delegates originating from the financial sector of China, Turkey, the UK, Iran, Korea, Belgium and others.





The event was opened by the plenary session "Integration Processes in Financial Markets: Eurasia and the Global Economy", moderated by Deputy Chairman of the Board of the National Settlement Depository, Maria Krasnova (Russia), and joined by representatives of supranational structures, exchanges and depositories of Korea, Luxembourg, Kazakhstan and Russia. During this session, the speakers discussed the current state and prospects of integration processes in the financial markets of Eurasia and set the tone for all subsequent discussions.





During the conference representatives of such organizations as the Central Securities Depository of Turkey, Astana International Exchange, FEAS, JSC INFINITUM, Bourse Consult, Cbonds, SWIFT, etc. made presentations on various aspects of the financial integration in depository and exchange activities.





The closing panel session was devoted to the role of financial market infrastructure in integration processes. The moderator of this session, IAE Executive Director Alexei Kuprin, discussed in detail with the representatives of infrastructure organizations of Belarus, China, Kazakhstan and

Russia current and promising mechanisms and solutions that banks, depositories, exchanges or supranational associations can develop to stimulate regional and global integration.





During the conference, memoranda of understanding were signed between:

- The Central Depository of the Kyrgyz Republic and the Central Depository of Armenia;
- The Central Depository of the Kyrgyz Republic and the Central Depository of Turkey.

As usual, the annual General Meeting of the AECSD Participants was held within the framework of the conference, in which representatives of members and observers of the Association discussed the prospects and results of participation in international initiatives. Among the Agenda topics there were: the 2019 WFC conference in Morocco and the WFC2021 in the Czech Republic, the Single Disclosure Initiative project, a unified format of association profiles within the WFC, the E-learning initiative, the success of cooperation with Asia-Pacific CSD Group and further development of interaction with other regional associations of central depositories. A number of Secretariat projects were presented to the Association members: further development of the site, organization of training seminars of AECSD, new functionality and composition of the Association's working groups, etc.







Upon the decision of the members the Chairmanship in the AECSD passed to the Central Depository of Armenia, and the President of the CDA, Vagan Stepanyan, became the new Chairman of the Association.

The next International Conference of the Association of Eurasian Central Securities Depositories will be held in the Republic of Armenia in 2020.
