# Capital market reforms in Uzbekistan

Since 1 May 2021, the function of the Capital Market Regulator has been transferred to the Ministry of Finance of the Republic of Uzbekistan (PP RUz-5073 dated 13 April 2021 "On measures to further improve the capital market regulation system")



The Program for the Capital Market Development in 2021 - 2023 was approved (UP RUz-6207 dated 13 April 2021 "On measures for the further capital market development")



The Roadmap for the implementation of the Capital Market Development Program in 2021-2022 was approved.

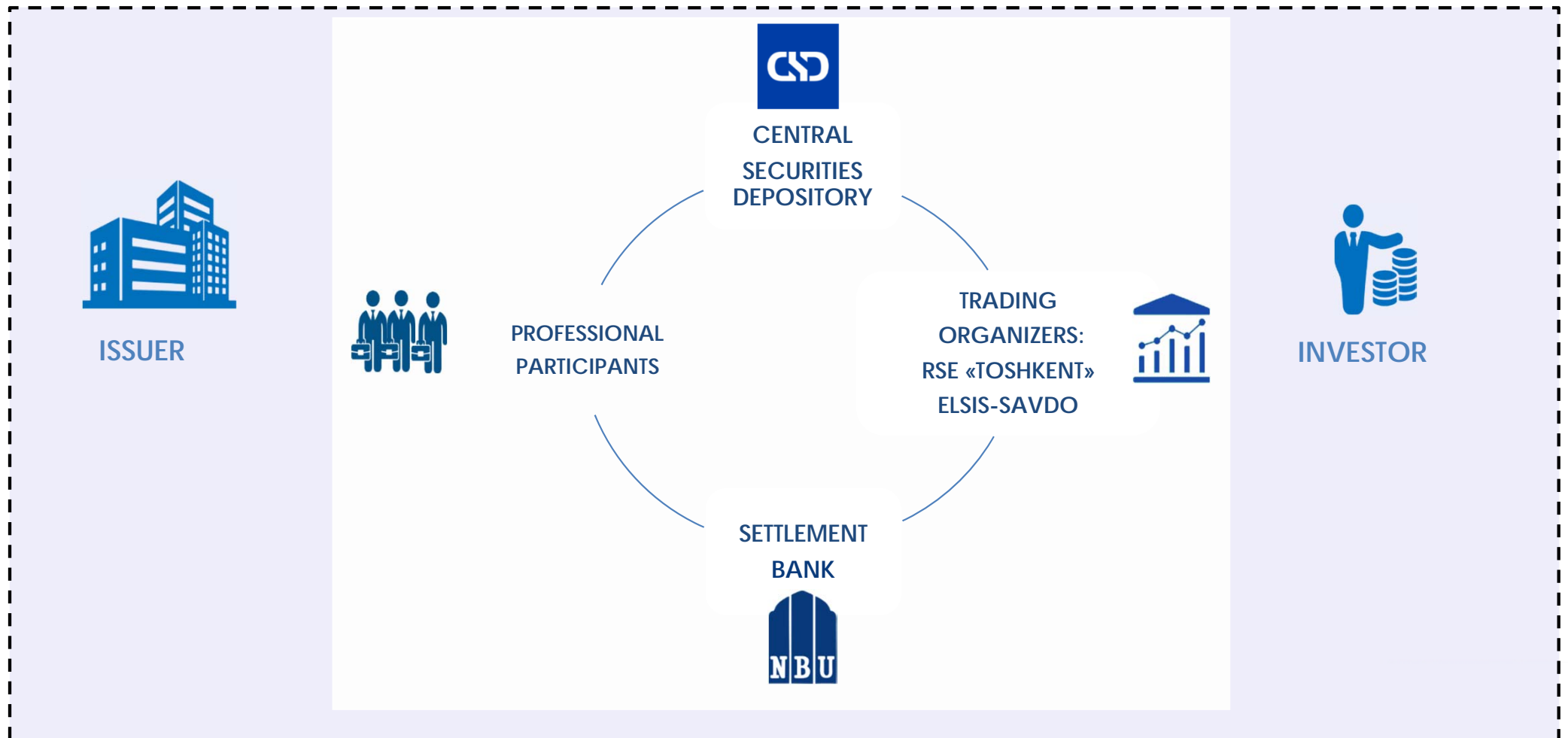

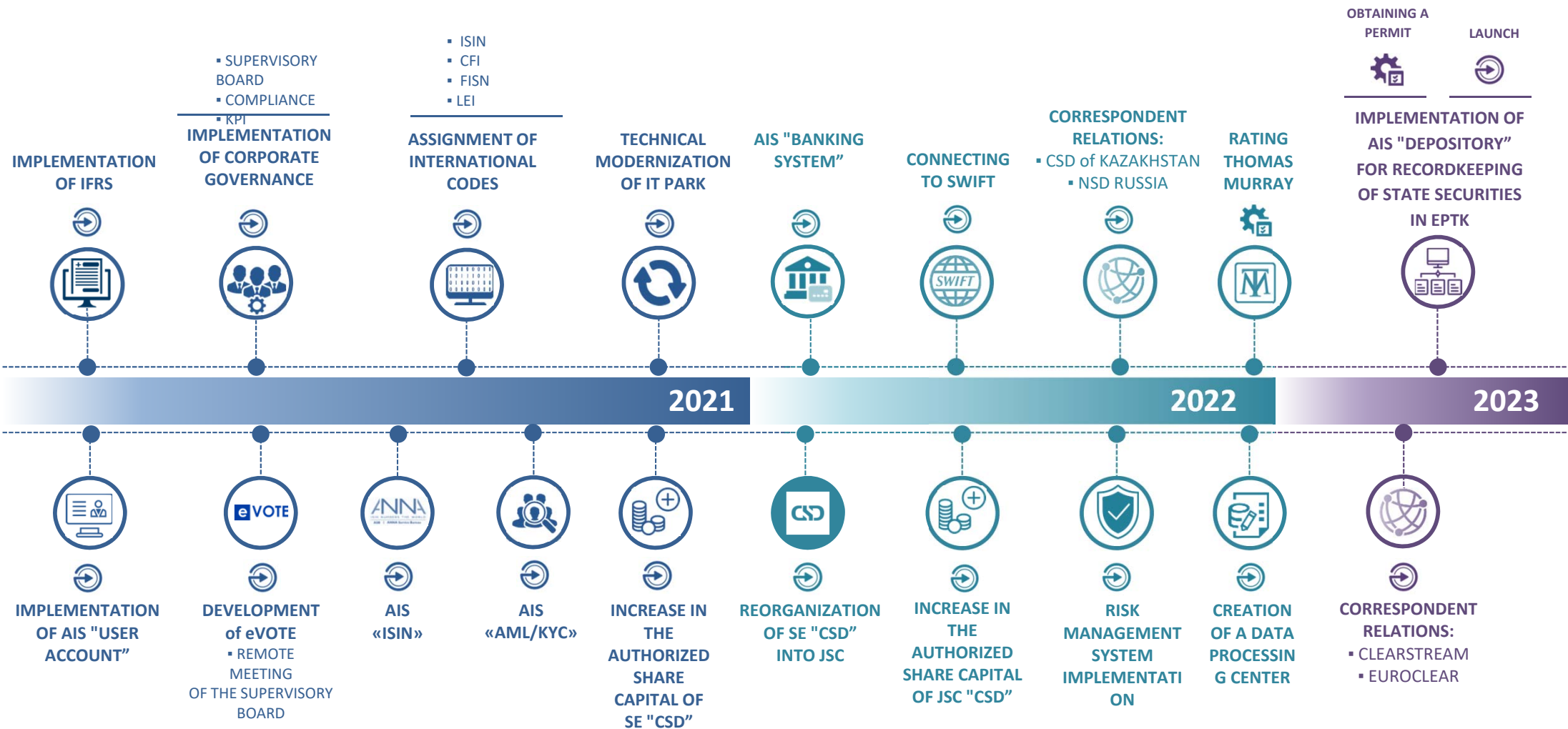
