






Global Indices Performance in 2022 vs YTD 2023



Majority of global exchanges rebounded in the beginning of this year









Foreign Investor Activities




Buying action on the stock market began to occur again after previously recording a significant net




Meanwhile, IDX issuance is growing steadily 41 companies in the pipeline as of June 16th 2023






Listing Growth on ASEAN Exchanges
